**Conditions of Approval:**

**This authority is in force from 1/07/2018 to 30/06/2019.**

- G 1** The authority holder is required to maintain a policy of insurance, providing cover of an amount approved by the Secretary, against any liability of the holder, or of a servant or agent of the holder, for death, injury or damage that arises out of or in connection with an activity authorised by the authority.
- G 2** The holder of this authority is required to comply with the 'General Standards for Exhibiting Animals in New South Wales'.

- G 3** The holder of an authority must cause the authority to be at all times publicly displayed in a prominent position at the premises at which the animals concerned are being displayed.
- G 4** That any proposed changes to animal accommodation are submitted to Department of Primary Industries for approval before being carried out.
- G 5** Animals shall be kept at the above address when not being exhibited at a mobile establishment or being transported to or from an exhibition at a mobile establishment.
- G 6** The holder of this authority is required to comply with the 'Standards for Exhibiting Animals at Mobile Establishments in New South Wales'.
- S 1** The authority holder must provide a display area which is designed so that the animals cannot escape, whilst they are being fed and held by members of the public.
- S 2** The authority holder must provide all the animals with sufficient shelter to allow protection from wind, rain and extremes in temperature, whilst on display.
